1. Rehearsals and performances are mandatory. Appointments, work schedules, family gatherings, etc. will be scheduled around regular rehearsals and performances.

_____ We have received the list of performances known to date as well as understand the regular rehearsal schedule. All efforts will be made to plan ahead and be in attendance at all rehearsals and performances.

_____ Rehearsal and performance dress codes will be followed. We understand that failure to follow dress codes may result in removal from said rehearsal or performance.
